FOUR ROUNDS, SWISS SYSTEM ... TIME CONTROL G/60 D5 ... IN 2 SECTIONS:

Open Open to all USCF members, but not recommended for members whose USCF Regular ratings are under 1500. **ENTRY FEE:** \$33 if rec'd by May 9, or \$40 at the tournament site.

PRIZES:* \$250 • \$150, U2250 \$100, U2050 \$100, U1850 \$100.

Under 1650 Open to USCF members whose USCF Regular ratings are under 1650 or who are unrated by USCF. **ENTRY FEE:** \$28 if rec'd by May 9, or \$35 at the tournament site.

PRIZES:* \$150 • \$100, U1450 \$90, U1250 \$70, U1000 \$50.

* These prize amounts are based on 20 players in each section.
None of these prizes will be reduced by more than 25%.

*An unrated player may enter either section but may not win more than \$80 in the **Under 1650**.
Unrated players are eligible only for place prize money and may not win any of the "U" prizes.*

Registration for at-site entrants: 8:30 to 9:35 AM. **Rounds** at 10:00 AM, 1:00 PM, 3:45 PM, 6:30 PM.
Optional half-point bye available for any one round if requested before start of play in Round 2.
No player may receive both a half-point bye and a full-point bye.
